Who is eligible?

The PNM Advanced AC Tune-Up Program is for all non-residential customers.

Program requirements:

- Average annual energy use of less than 750,000 kWh
- Unit size of at least 3 tons or greater
- Unit must be at least 3 years or older
- At least 5 years since last PNM Advanced AC Tune-Up service
- The energy savings resulting from diagnostic maintenance must occur on a meter with an eligible rate schedule

¹Note: if your system requires additional refrigerant or other repair to restore full functionality, you may incur an additional charge for those services. Your system must be operational prior to completing a tune-up. Your contractor will notify you if they are unable to perform the tune-up service and inform you of the next steps.
